CONTRACT OF NEWS SUBSCRIPTION

KNOW ALL MEN BY THESE PRESENTS:

This Contract of News Subscription to the General News Service of the Philippine News Agency (PNA) is entered into in Manila this ____ day of _____ 202 by and between the **NEWS AND INFORMATION BUREAU – PHILIPPINE NEWS AGENCY**, with office address at 2nd Floor PIA Building, Visayas Avenue, Barangay Vasra, Quezon City, represented herein by **DIR. RAYMOND ROBERT C. BURGOS**, Director IV, referred to as the **NIB - PNA**;

and

____ (company name) with office/business address at _____, represented herein by _____, referred to as the **SUBSCRIBER**;

Do hereby agree, as follows:

1. **SERVICES:** The NIB-PNA shall grant the **SUBSCRIBER** the exclusive right and privilege of using the PNA's General News Service (**Excluding Foreign News**) hereinafter referred to as **NEWS SERVICE**, for news and information purposes of the **SUBSCRIBER**;
2. **DELIVERY:** The NIB-PNA shall promptly deliver the **NEWS SERVICE** thru its website.
3. **USAGE:** The **SUBSCRIBER** shall **not distort** the substance of the news and features and **shall credit** the **AUTHOR** and **Philippine News Agency** for the articles used. The **SUBSCRIBER** shall be the sole user of the **SERVICE** and shall not make the **SERVICE** available for syndication or to anybody who is not a party to this Contract.
4. **PAYMENT:** The **SUBSCRIBER** shall pay the total amount of _____ for _____ (type of subscription) as subscription fee for six (6) months. The rate, herein agreed upon by both parties, is in accordance with the established subscription rates. Payment should be made within a month thru cash, check or bank remittance to the NIB Current Account at Land bank of the Philippines. Additional fee/charge on bank transfer or remittance shall be shouldered by the **SUBSCRIBER**. **NIB – PNA** shall issue an Acknowledgement Receipt for bank remittance/transactions which will indicate the total amount of subscription rate/fee. Otherwise, an Official Receipt (OR) will be issued upon request by the Subscriber.

Pursuant to the Executive Order No. 297, series of 1987, Section 18 under the Transitory Measures, "The Philippine News Agency is authorized to sell their services at rates not less than those offered by comparable private firms, provided, that income realized shall be deposited with the National Treasury and shall accrue to the General Fund."

5. **TERMINATION OF CONTRACT:** All the terms and conditions herein stipulated shall be in effect for the duration of the contract unless earlier terminated by either of the parties in which case the party wishing to terminate the Contract shall send a written notice to the other party at least THIRTY (30) days before termination date.

In case of violation of any provisions of this contract, the First Party may terminate immediately, and no payment refund will be provided to the Second Party.

6. **DURATION OF CONTRACT:** This Contract shall take effect for the duration of **SIX (6) MONTHS** upon payment of the **SUBSCRIBER** within the thirty (30) working days period. Failure of full payment on the prescribed time/duration shall mean termination and the **SUBSCRIBER** is obliged to pay the one month fee as soon as possible.

7. This written Contract shall represent an understanding between the **NIB - PNA** and the **SUBSCRIBER**, and any verbal/oral representation of agreement by any agent/s or other parties shall be null and void, and of no effect whatsoever.
